DECLARATION OF EASEMENT

THIS DECLARATION OF EASEMENT made this 24th day of June, 1997, by and between WOODLAND DEVELOPMENT COMPANY, a Michigan co-partnership, whose address is P.O. Box 1138, Kalkaska, MI 49646 ("Woodland"), and DOUGLAS H. FLORIA and MYRTLE M. FLORIA, husband and wife, whose address is 10209 Burgandy, Diamondale, MI 48821 ("Floria").

RECITALS:

WHEREAS, FLORIA heretofore sold the following described property to Forest Development Co., a Michigan co-partnership, on a Land Contract, pursuant to a Land Contract dated February 23, 1996, as evidenced by a Memorandum of Land Contract recorded March 1, 1996, in Liber 367, Page 151, Charlevoix County Records, to-wit:

Peaine Township, Charlevoix County, Michigan: The West half of Section 20, Township 38 North, Range 10 West; AND

WHEREAS, Forest Development Co., a Michigan co-partnership, thereafter assigned their Purchaser's Interest in Land Contract to WOODLAND as evidenced by Purchaser's Assignment of Land Contract dated February 23, 1996, recorded March 1, 1996 in Liber 367, Page 152, Charlevoix County Records, and

WHEREAS, Woodland wishes to establish and sell Parcels 1 through 23, inclusive, to be known as "ISLAND HIDEAWAY", as more fully set forth in Survey recorded in Liber 377, Page 151 through 159, Charlevoix County Records, and

WHEREAS, Woodland desires to declare and establish Easements for Ingress and Egress and the installation and maintenance of public and private utilities both above and below ground for the use and benefit of the respective Parcels 1 through 23 of Island Hideaway and for the use and benefit of WOODLAND (and Floria's) remaining lands located in the West one-half (W 1/2) of Section 20, Township 38 North, Range 10 West, shown as "Parcel R" on the attached Exhibit "A".

NOW, THEREFORE, in consideration of \$1.00 and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

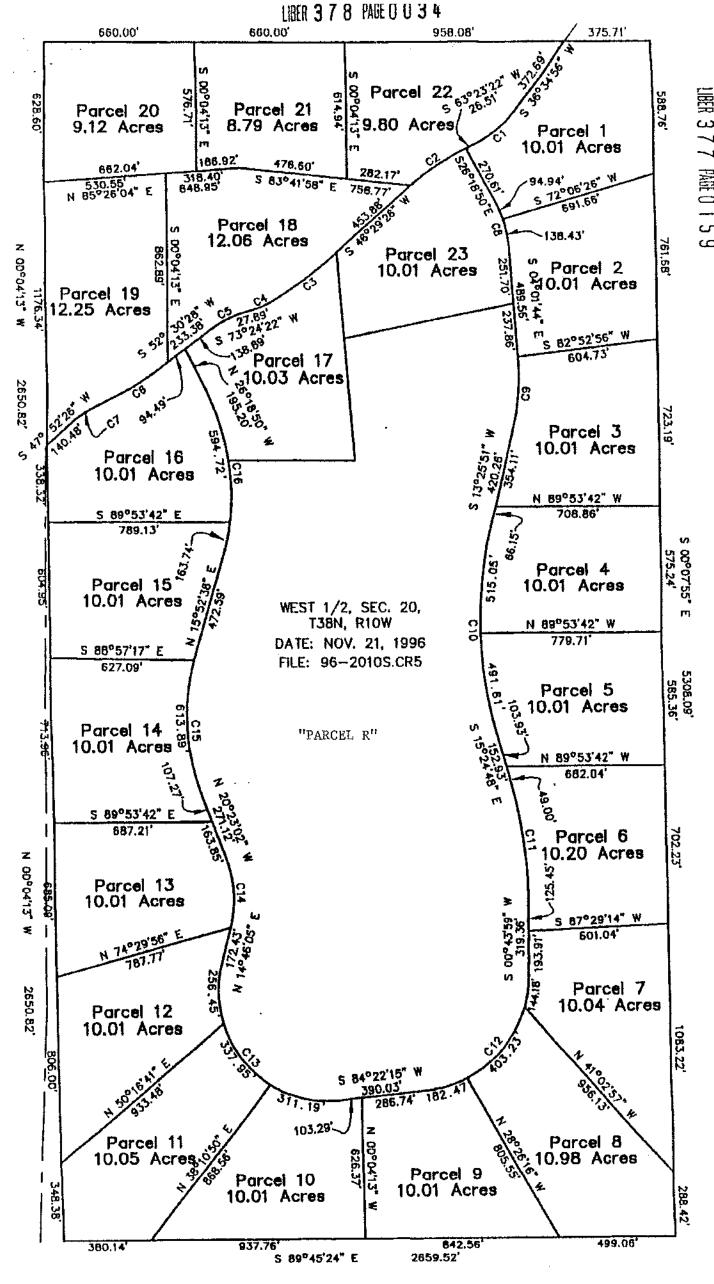
- (1) There is hereby declared and established a 66' wide "Easement A", a 66' wide "Easement B", and a 30' wide "Easement C", as more fully set forth on attached Exhibit "B" which shall be non-exclusive easements for ingress and egress and the installation and maintenance of public and private utilities both above and below ground, for the use and benefit of Parcels 1 through 23 inclusive of the Island Hideaway development and "Parcel R" as referenced herein.
